Community based elder abuse is a pervasive public health and criminal justice issue affecting 1 in 10 older adults in the US.



For every 1 case of abuse that is reported, 23 more go unreported.

90% of cases involve a family member as the perpetrator of abuse, resulting in older adults needing shelter and medical care due to unsafe living situations.

The Weinberg Center provides short-term housing, comprehensive healthcare, legal advocacy, and therapeutic services for older adults 60 years and older experiencing abuse.

Since inception through December 2017, we have provided 109,308 days of shelter.


### **Referral Sources**

**Professional referrals** provide prompt access to the Weinberg Center team for assessment to determine shelter eligibility.

In 2017, **88 clients were referred to the shelter program**, with more than half coming from hospitals and social service agencies.

**85 consultations were provided by the Weinberg team** to professionals and community members on elder abuse cases or shelter inquires.



### **Admissions**

Once admitted, each client receives **individualized and comprehensive coordinated care** provided by the Hebrew Home's medical and professional staff. The Weinberg Center's multidisciplinary team develops a **holistic and trauma-informed action plan** based on each client's particular circumstances and goals. **Civil legal services** are a cornerstone of our work, and can include obtaining Orders of Protection, representing clients in Housing Court, or advocating in a guardianship proceeding.


In 2017, 23 clients were admitted into the Weinberg Center's elder abuse shelter program.

# Types of Abuse

It is common for older adults to experience multiple co-occurring or sequential types of abuse by one or more perpetrators. The majority (78%) of our clients experience more than one type of abuse, with financial and emotional abuse being the most frequent types.



### Serving Our Community

#### **IT'S YOUR CALL**

It's Your Call is the Hebrew Home at Riverdale's comprehensive employee domestic violence prevention and intervention program, the first program of its kind in a long-term care facility. Every staff member at the Hebrew Home at Riverdale is provided with domestic violence training, a domestic violence resource list, and support network within the Home, including access to campus security. 1 in 4 women in the US is or has been a victim of domestic violence, so it's a fact that domestic violence is a part of the lives of our employees as 75% of the over 1,000 staff members are women.

**34 employees are currently trained as "lighthouses"**, meaning they are available to all staff for private discussions about domestic violence related incidents, serve as a source of support, and as a way to access Hebrew Home's resources.

### BROOKLYN LAW SCHOOL HELP CLINIC: "Helping Elders through Litigation and Policy"

Under the leadership of the Weinberg legal team, the **HELP Clinic** combines students' elder law practice in Family Court, Criminal Court, Housing Court, and guardianship proceedings in Supreme Court with a seminar that addresses the broad spectrum of legal areas in which elder abuse can play a critical role. Students are placed at a legal organization, such as Brooklyn Legal Services, JASA's Legal/Social Work Elder Abuse (LEAP) Program, Vera Institute of Justice, and the NYLAG Evelyn Frank Legal Resource Program. Since it began in 2013, **the HELP Clinic has provided a legal foundation for issues affecting older adults to 35 students**.

#### THE SPRING ALLIANCE

The Weinberg Center continues to foster replications of the shelter model around the country. **The SPRING Alliance** (Shelter Partners: Regional, National, Global) is a network of elder abuse shelters with close working relationships, shared expertise, and a vibrant community of support. Since 2005,



there have been 13 shelter replications across 12 states.

#### **COMMUNITY OUTREACH & EDUCATION**

Education, training, and consciousness-raising are a core part of the Weinberg Center's mission. We train medical professionals, social workers, law enforcement, judges, attorneys, case workers, and aging service professionals. We are particularly focused on nontraditional audiences, such as building service workers and Meals on Wheels volunteers, who are often well-positioned as first responders to the red flags and patterns of abuse. This is critical to bringing elder abuse out of the shadows.


#### In 2017, we provided:

# Safety Screening

A safety screen tool to assess for elder abuse is performed with every older adult in RiverSpring Health, including patients on sub-acute rehab, newly admitted long-term care residents, and clients in our managed long-term care plan. The Weinberg team conducted immediate follow-up for 50 sub-acute rehab patients who screened positive for the risk of elder abuse. Follow-up services include safety planning with the client or family member, providing legal advice, making an APS referral, and offering the possibility of entering our shelter program.

10.5% of the 474 screens performed on sub-acute rehab screened positive for elder abuse.
